1. At references A and B, the Investment Committee granted authority to Host Nation NCI Agency to issue the invitation for bids and to commit NATO funds for relocation of the STVF from Glons, Belgium to The Hague, The Netherlands (NSIP serial 2013/5VA03999).
2. Consequently, the NCI Agency has issued the Notification of Intent (NOI) at reference C on 6 June 2018, requesting NATO Nations to nominate qualified firms for this IFB by 15 July 2018.
3. The IFB package has now been finalized and IFB-CO-14798-FGFS is expected to be issued shortly.
4. The Contracting Officer in charge of this procurement had to take a sudden leave of absence on medical grounds. The NCI Agency has tentatively established the Prospective Bidders list from the Declarations of Eligibility (DoE) found in the project file. In the absence of the Contracting Officer, however, the NCI Agency is not in a position to verify the accuracy or completeness of the Bidders List and is thus compelled to delay issuance of the IFB until all nominated bidders have been confirmed.
5. Hence, the NCI Agency would kindly request all NATO Nations to transmit their nominations and DoE previously sent to the NCI Agency along with any new nomination, to the below point of contact who will also act as the new Contracting Officer for this IFB.
